4. Superintendent's Update (continued): Timestamp: 25:52 - 36:50

A sprinkler head in the new Colonial building leaked many gallons of water one weekend. Mr. Davidick and Dr. Russ expressed their gratitude for the prompt response of Mr. Dewease, division maintenance, and the Botetourt Fire Department, whose actions helped mitigate the damage.

Two industrial hygienists will be conducting mold testing at Lord Botetourt HS on Monday, February 14. The results can take 5-10 days, at which point a report will be shared with the board and at the next board meeting.

BCPS will also be performing air quality assessments at all our schools, pursuant to other orders contained in Governor Youngkin's E.O. #2.

The technology department will use awarded funds to replace staff and student devices that are at end-of-life and due for replacement. The department is also instrumental in submitting several required state reports.
