What Is Title I?

Title I of the Elementary & Secondary Education Act is a supplemental program in reading, language arts and mathematics. The program helps children to attain high levels of achievement through the implementation of challenging content and performance standards.



Who Can Attend Title I Classes?

Any child who resides within the boundaries of the five qualifying schools and is achieving below his or her potential in reading, language arts and/or mathematics according to federal guidelines, is eligible to attend.

The five schools are Greenfield, Breckinridge, Buchanan, Eagle Rock, and Troutville. Students in kindergarten - grade 5 are served in reading / language arts and mathematics.



What Will My Child Do In Their Title I Class?

Title I Students improve their reading, language arts and/or mathematics abilities using many skill related activities.

These activities

- ~ engage students in successful learning experiences which are positively reinforced
- ~ consider prior student learning and learning styles
- ~ involve small group and individual instruction
- ~ focus on increased student performance
- ~ provide continuous assessment of students and
- ~ use technology as a tool for learning.
